Approved List of Security Prescription Printers

January 23, 2019

Dear Health Care Provider/Prescriber,

As of Monday January 1, 2019, the Health and Safety Code section 11162.1(a) (15) requires prescription forms for controlled substances to be printed with a unique serialized number.

Provider/Prescriber's must order tamper-resistant forms from security prescription printer companies that have been pre-approved by the Department of Justice (DOJ).

Please choose a security prescription printer from the list below and contact the company directly to place an order for the new tamper-resistant prescription forms. Prices may vary. You will need to have your prescriber's state license number and a copy of the prescriber's Drug Enforcement Agency (DEA) Registration when you place the order.
